The Board headed by the Station Officer, Fire & Rescue Station Kottarakkara had inspected G+2(Block 1), G+2(Block 2) storied 11.25 meters(Block 1) , 11.25 meters(Block 2) height Educational Building in Survey No.428, 431 in Ezhukone Village in Kollam District under Ezhukone Grama Panchayath owned by Sri.K.Suresh Kumar, Manager, Sree Narayana Guru Central School, Ezhukone.P.O., Kolannoor, Kollam and recommended to renew Certificate of Approval No.B-5078/2021 Dated. 31.12.2021 of the Regional Fire Officer, Fire & Rescue Services , Thiruvananthapuram for the occupation of the said building as per the report No.KTR/05/2024 Dated.04.01.2024 of the Station Officer, Fire & Rescue Station Kottarakkara for one year.

2. In the circumstances, this. Certificate of Approval is issued under my seal and authority for the continued occupation of the above building. No further construction will be allowed in the vacant spaces provided in the approved plan.

3. This certificate is issued on the condition that the fire fighting system installed will be kept always functional and the owner of the building should take special care to maintain the system installed in proper working condition. **This Certificate is valid for one year from the date of issue. After one year the Certificate must be renewed. Non renewal of certificate within the time limit will result in the loss of eligibility for insurance coverage and appropriate legal action by the Local Self Government/ Revenue Department.** All officers of and above the rank of Station Officers of the Fire & Rescue Services Department will have the right to inspect the building on any day/time after serving 7 days notice to ensure that the installed systems are in good working condition.
